

Terms and Conditions

1. Disclaimer

These Terms govern your use of:

- iPlace (you may know this as the "My Place Portal");
- the My Place website, www.myplace.org.au (Website);
- My Place's social media pages; and
- other information communication technology (ICT) that My Place offers.

You agree to be bound by the following terms and conditions by visiting and using iPlace, the Website or the ICT.

References in these terms and conditions to "My Place" includes My Place WA Ltd ABN 80 784 853 864 and other related entities, where the context requires.

2. Copyright

The information provided in iPlace, and its design, text, graphics and software, are (unless otherwise stated) copyright of Individualised Solutions Australia Pty Ltd ABN 35 080 401 252.

You are granted a revocable license to download the materials contained in iPlace for your personal use, including for the purpose of transacting with My Place. You must not otherwise modify, copy, reproduce, republish, frame, upload, post, transmit, distribute or provide a link to the contents of iPlace in any way, except as expressly provided for on the iPlace, or with the written authorisation of My Place WA Ltd.
